There is no charge for Arch Review. Feedback from meeting attendees: there could be extra fees associated with ground mount vs. house mount solar. One homeowner encountered extra fees from county when doing ground mount.

TREE & FIRE SAFETY MICHAEL LADEAUX

DISCUSSION

Preliminary letters were sent out to properties with tree issues. Reminder that trees need to be trimmed 6 ft from road and 14 feet above. Weedeating needs to be done 30 feet from structures. There is a possibility for grant money to be available from the ED County Fire Safe Council. They work with the CCC to get properties cleared. There is a free chipping program available through Fire Council. Information is on our website under "Fire Safety". Safety suggestion for Ranch residents: some homes don't have a visible street address that is easily seen from the street. Make is easier to be found by emergency services, etc.

NEW BUSINESS BOARD

The Bus Barn: hasn't been used in at least 15 years since bus does not enter Ranch anymore. Sean McDermott will take it, if no other interest.

Welcome Packet: Mike and Ali worked to put together welcome packet for new residents. Contains pertinent information that will be helpful to new residents. Will also put on website and Facebook group (will black out gate code, so it's not public info)

Gate Code: will change December 1st. New gate code will be emailed out to Ranch residents and also sent by mail along with Assessments bills. As a reminder, if you are having a large party, garage sale, etc. you can request the gate be left open. You can also request a short term code for use by contractors.
